Don't Overlook this Tax Deduction

Submitted by Toepel Company PC **→** axpayers often overlook the medical expense deduction. While this deduction is subject to limitations, with today's high cost of health care, many people can surpass these limitations and get real tax savings by keeping track of their annual medical costs. As long as

you itemize your deductions instead of taking the standard deduction, medical expenses that exceed 7.5 percent for tax year 2018 (10 percent for 2019) of your adjusted gross income could be deductible.

The cost of health care has skyrocketed. According to the Centers for Medicare and Medicaid, the average amounts spent by a person are well over \$10,000 a year.

Here are some often-overlooked medical expenses:

1. Medical Expenses in General

Medical costs can be deducted, related to the diagnosis, treatment, cure or prevention of disease or costs for treating any part of the body. Those include equipment, services and supplies, ranging from eye glasses to eye surgery, from acupuncture to prescriptions. Dental expenses also are among the costs some people ignore, including dentures and artificial teeth. Even artificial limbs, bandages, hearing aids and wigs are accepted medical expenses. And don't forget health insurance premiums.

2. Long-Term Health Care Costs

An often-missed expense is the amount paid for long-term care services and long-term care insurance. Rehabilitation, therapeutic, preventative and personal care services are among those that qualify as long-term care services, if your family member is chronically ill and if it is part of a plan set by a health care practitioner. Someone is considered chronically ill if he cannot perform at least two activities of daily living, such as eating, toileting, bathing and dressing, without substantial assistance from someone else.

3. Mileage

From weekly doctor's appointments, to out-of-town visits with a specialist, or for a procedure, the miles you log while driving to meet medical needs can be deducted.

4. Home Improvements for Aging and **Special Needs Adults**


Investing in ramps for a wheelchair, handrails and grab bars in the bathroom, or a stepless shower can be part of the deduction, as long as it doesn't add value to the home. The IRS says that the cost of the improvement is reduced by the increase in your property value. Other changes, such as widening doorways and hallways, lowering kitchen cabinets and installing lifts, also typically do not add value to houses.

The IRS Publication 502 details the medical deduction. It is available online at irs.gov/publications/p502.

For those who do want to shop in person, they will enjoy an improved experience at the larger space, which is set up to display the furniture the same way it would be set up in a home.

"My customers love it," said Robin.

"People say, 'Oh, my gosh, it's like a showroom.' They come in and say they can't
believe how big the store is and how many
more things I have, and how well laid out
things are so that it's all easier to see."

All-girls robotics team embraces **TEAMWORK AND INNOVATION**

t Fremont Junior High School, the Girls Out Loud robotics team is blazing a trail for future

Seventh-graders Lucy Boyer, Sofia Carroll Covarrubias, Kassidy Lopez and Payton Maguire have been friends since kindergarten. In fifth grade, they realized their different schedules and interests made it challenging to stay connected. The friends looked for a learning opportunity to allow them bonding time and, most importantly, having fun. Robotics fit the bill.

Zaharis Elementary School gifted and talented teacher Patrick Carroll came on board as coach. At the time, the girls never dreamed that their hard work eventually would take them to the state competition at Arizona State University this past January.

The Girls Out Loud team motto is, If you had fun, you won. It's easy to understand the students' enthusiasm for robotics.

"Robotics is so much fun," Lucy said. "When we first started, we didn't know how to program robots, or what we were doing. We just knew we were having a blast, and now we focus on the experience, our teamwork and improving our scores."

SPACE EXPLORATION

First Lego League is celebrating its 30th season of challenging students to think like scientists and engineers through problem solving and teamwork. This year's theme transports students into space to solve a problem that astronauts can experience.

Girls Out Loud chose to address the unique social and confinement issues astronauts face on their long voyages in space by using virtual reality technology. In September, the team began working on a prototype of red and black virtual reality glasses. The goal is to provide astronauts with a virtual reality experience to help them feel connected to Earth.

"We knew we wanted to make the glasses sleek and build the computer into the lenses," Payton said.

After speaking with experts from NASA and SAP Hybris, the students learned that astronauts require two hours of daily exercise to maintain bone density and muscle strength in a microgravity environment. Infusing their exercise time with a virtual reality experience would add variety to their schedule, helping astronauts stay mentally healthy and happy.

"Astronauts have limited space to move around, and the glasses are designed to enhance their treadmill and stationary bike experiences," Kassidy added.

The team added earbuds to the glasses, providing sounds of the real world, which elevates the experience.

"Now they can run on the beach, bike in the woods or play a game of tennis or golf," Sofia shared.

The team qualified for state after competing in the regional tournament. At regionals, Girls Out Loud received the Project Award for fully embracing their core values, while achieving excellence and innovation in the robot game and project. At the time of this Up Close printing, results from the Jan. 19 state competition were unavailable.

New Medicare Enrollment PERIOD STARTS THIS YEAR

The Medicare Advantage Disenrollment Period lets you drop your Medicare Advantage plan and return to Original Medicare (Part A and Part B). It also lets you sign up for a stand-alone Medicare Part D prescription drug plan.

In 2019, a new Medicare Advantage Open Enrollment Period will run from Jan. 1 through March 31. If you are enrolled in a Medicare Advantage plan, you will have a one-time opportunity to:

- Switch to a different Medicare Advantage plan
- Drop your Medicare Advantage plan, and return to Original Medicare, Part A and Part B
- Sign up for a stand-alone Medicare Part D prescription drug plan (if you return to Original Medicare)
 So, why would you want to switch to a different
 Medicare Advantage plan?

All Medicare Advantage plans have certain benefits you can always count on. Many include coverage beyond Original Medicare (Part A and Part B). However, these extra benefits (beyond Part A and Part B) can change year-to-year.

Skin Cancers Affect Millions of People Each Year

kin cancer is expected to affect more than 3 million people in the United States this year alone.

This number represents more cases of cancer than all other cancers combined. Most of these cases are the nonmelanoma skin cancers, which include both basal cell carcinoma and squamous cell carcinoma. People living in Arizona are more prone to these types of skin cancer because of our high altitude, low latitude and our very warm climate. This is important

because most people living in Arizona spend time outdoors all year round. Arizona will have more cases of skin cancer than any other state in the country.

These nonmelanoma skin cancers generally will present as non-healing, painful or bleeding lesions. However, many of these lesions can present without any symptoms at all. The sooner these lesions are detected, the easier the course of treatment will be in the long run. Nonmelanoma skin cancers can be treated with various medical and surgical procedures.


The more aggressive types of skin cancers are melanomas. It is estimated that more than 1 million Americans are living with melanoma. The American Academy of Dermatology estimates there will be more than 178,000 new cases of melanoma in 2018.

If melanomas are caught early and do not spread to lymph nodes, the five-year survival rate is roughly 99 percent. However, if there is regional or distant spread to lymph nodes, this percentage drops down to 63 percent and 20 percent respectively. Therefore, observation of moles or any new dark spots on the skin should be monitored closely.

Patients should be looking for moles and new dark areas that are:

- 1. Asymmetric
- 2. Irregular bordered
- 3. Dark with multiple colors
- 4. Diameter greater than 5 mm
- 5. Evolving or changing moles

If caught early, even melanomas can be surgically removed before they spread.



BE INFORMED ABOUT ALTERNATIVE WAYS TO SELL YOUR HOME

ecently, I had the pleasure of doing my first public speaking engagement at the Retired Employees City of Mesa (RECOM) meeting.



One of the topics we discussed was the pros and cons of selling your home to the Internet buyers known as iBuyers instead of doing a traditional sale. It was a very interesting meeting and a topic I thought would be helpful to everyone, whether you are considering using an iBuyer or just curious about how it works. This topic raised a lot of questions, so I thought it would be a good topic for this month's article.

WHAT IS AN IBUYER?

An iBuyer is an online company, such as Opendoor, Offerpad and Zillow. They will send you an offer to purchase your home via email within minutes (or days), sight unseen, based on their valuation model and the information you provided them.

BENEFITS OF SELLING YOUR HOME TO AN IBUYER

- You can sell quickly.
- There are no showings.
- You don't need to get your home show ready.
- You don't have to do any repairs (but you will pay for
- Sell on your schedule—choose when you close.

NEGATIVES TO SELLING YOUR HOME TO AN IBUYER

- The purchase price will be well below market value.
- Service fees are higher than the traditional Realtor
- The cost often is much higher for repairs than a traditional sale.
- Communication may be harder with an iBuyer, especially on evenings and weekends.

WHAT THEY CLAIM AND WHAT IT REALLY **MEANS**

iBuyers claim there are hidden costs you have to pay on a traditional sale that they avoid, such as:

- Realtor Fees: This is true. You don't pay Realtor fees. However, they will charge you a service fee (I have seen as much as 9 percent).
- Closing Costs (1 percent): You as a seller will have to pay closing costs no matter to whom you sell. In some instances, iBuyers will ask you to pay for buyers closing costs as well, which is not traditional.
- Risk of Low Appraisal: The reason you don't have to worry about a low appraisal on an iBuyer sale is not because they don't do appraisals, but because their purchase price is always way under the market value.
- Staging and Home Preparation (1 percent): While it is true you will want to declutter and get your home ready to show, it's very rare sellers spend money on home staging. Usually, the seller can use items they already have, and decluttering and rearrange furniture is all that is needed, at no additional cost.

If your home needs painting, iBuyers will charge you the cost to repaint in the repairs demand, which will reduce the net price. In a traditional sale, you may not have to paint your home, but if you do, you can usually recoup the cost in the sales price.

- Seller Concessions (1.5 percent to 2 percent): Some buyers ask for the seller to contribute to the buyer's closing cost. This will be part of the negotiation of the contract, and closing costs are included in the purchase price. So, the net to the seller does not change. Closing costs really don't make any difference to the seller's net proceeds.
- Repair Costs: On a traditional sale, this is another negotiation, and a buyer might ask for only a few items to be repaired. With an iBuyer, they will do an inspection and give you a list of all the items they want you to repair, or they will charge you a set fee for these repairs. This usually is a lot higher than repairs in a traditional sale.
- Home Ownership and Overlap Costs (1 percent): This is a fee they claim is for the cost of housing during transition. However, a lot of sales are done

simultaneously nowadays, so there is no transition period. If there is, it's usually just a few days, but even if a short-term rental were needed, it still would be far less expensive than all the fees and lower price.

You would think technology would bring down costs, not increase them. Remember, though, these buyers are investors, not traditional buyers. They have to add on all the fees and pay way under market value so they can flip the home and make money.

We asked Opendoor, Offerpad and Zillow to give an offer to purchase one of our properties. The same information was given to all three iBuyers.

I ran the comps and estimated the home value as \$440,000, but was conservative with a sales price of \$420,000. Here is a chart showing the offer price and fees from each company.

As you can see, by choosing an iBuyer, the seller would lose between \$48,000 and \$62,000 over a traditional sale.

Selling to iBuyers may be a great option for some sellers. It allows for convenience and a quick sale. For sellers looking to maximize the proceeds from the sale of their home, iBuyers probably aren't the best choice for you.

Has a Rich History in Christian

T elebrating love on Valentine's Day is what I love to do, but ✓ maybe you don't know there really was a Christian Saint named Valentine, and many actually were named after the original.

Valentine lived in the late 200s in Italy. History swirls a lot of legend into it, but here are a few things traditionally believed about Valentine. He was a bishop when Christianity was illegal and persecuted. He was jailed for preaching of Jesus Christ, teaching that Jesus was God in flesh and blood, an offense to the Roman emperor who demanded that all worship only him. But Valentine preached of the Love of God through Christ.

During his confinement, Valentine shared Christ with the judge. The judge tested this God of the Christians by bringing his blind daughter to Valentine and demanding that he heal her. Valentine prayed and the girl was healed.

Valentine told the judge to remove all his idols, fast for three days and be baptized in the name of Jesus Christ. The judge did so, and, after three days, his entire household, 40 people in all, were baptized. Valentine was freed, and he continued to correspond with the girl he had healed.

He also continued to perform marriages for Christians, an illegal practice. But he believed in love, and brought God's blessing to couples seeking marriage. He

and taken to Rome to appear before Emperor Claudius II. He sought to convert the emperor to Christ and for that he was sentenced to death.


Before his execution, he left a final note for the girl healed of blindness, urging her to carry the love of Christ into the world. He signed the note Your Valentine. He was killed on Feb. 14, 269 AD or 273 AD, depending on the historian you read.

No one can say how much of the legend is true. But the Christian church established a day to commemorate the faith of St. Valentine in 496 AD, honoring his commitment to Christ and to sharing the love of God. He urged us to love one another as Christ had loved us.

Valentine proclaimed this from 1 John 4:7-9, "Dear friends, let us love one another, for love comes from God. Everyone who loves has been born of God and knows God. Joint Replacement Is Recommended

When Painful Symptoms Cannot Be Alleviated

any people struggle
with joint pain
throughout their lives,
and this can be caused by many
factors, but one of the most
common causes of pain is arthritis.

Arthritis is a type of joint degeneration whereby the protective cushion of the joint wears away, either due to repetitive use or due to an accident or injury. When this occurs, the joint will begin to grind, bone on bone, causing inflammation and painful symptoms in the joint.

The most common joints affected by this are the knees and the hips, although other areas of the body also can experience the same type of effects. Knee and hip pain eventually may require joint replacement surgery.

Joint replacement surgery is a type of orthopedic surgery in which a dysfunctional joint surface that has been damaged is replaced with an artificial surface. A physician typically recommends this when other treatments have not been successful in alleviating symptoms.

Other treatments could include activity modification, medications or injections. It is likely that with the other treatments you would see a physical therapist to attempt to improve the function of the joint, as well. If these treatments were ineffective, a replacement surgery would likely be recommended.

Following any surgery, you are likely to experience post operative pain, swelling and some limitations in your ability to complete activities, such as walking,



running or moving your leg due to these symptoms. Typically, these are temporary symptoms, and will begin to improve within a few weeks of your surgical date.

The use of ice to help control pain and swelling, as well as exercises given at the hospital, will be integral to your recovery over the first few days. Your surgeon most likely will refer you to physical therapy, whether in a home-based environment or to an outpatient clinic.

During physical therapy, you will complete exercises designed to improve your strength and mobility, improve your ability to walk independently, and reduce swelling and painful symptoms. Most importantly, the goal of the surgery and therapy is to get you back to doing the activities you love, and with less pain than you had prior to the surgery. Many people are able to return to hiking, biking, swimming, tennis and many other activities that are very important to their well-being.



ave a brilliant idea for a product or service that you're sure the world needs? You're not alone. More than 500,000 entrepreneurs take the plunge every month, according to the Kauffman startup index.



To begin with, this latest volatility may be due to a variety of factors, including rising interest rates, tariffs and trade concerns, and the anticipation of somewhat slower economic growth.


But rather than stressing out over these developments, try to focus on what you can control.






